Our Parish Council is made up of a maximum of nine councillors. Due to nine candidates being nominated a Parish Council election has not been necessary. We would like to thank all our Councillors for their continued support.

The County Councillor provided information on the 'Love Norfolk Hate Litter' campaign and Norwich to London by train in 90 minutes that starts in May. The District Councillor reminded the Parish Council of the South Norfolk Community Awards which close at the end of April. He congratulated the well-attended village fund raising events and everyone who supported them.

Members of the Parish Council had a review meeting on the draft conservation area map and consultation with South Norfolk Council's Conservation Officer, they discussed each of the proposed changes to the conservation area map and it was confirmed that the consultation will take place this summer.
