1. Play Area Management Policy

Overview

Pulham Market Playing Field

The Playing Field is located on Mill Lane, Pulham Market.

The site is cut under contract by TOP Garden Services (5 year contract terminating Oct 2026)

The Playing Field Working Group will inspect the equipment quarterly.

Annual ROSPA inspection arranged by Clerk.

Litter Picking and collection of the rubbish is undertaken by the South Norfolk Council and volunteers. In severe cases the village handy man may be asked to assist.

Budget

Council provides for maintenance of site and equipment in its budget and has a reserve fund for new equipment which is required to be approved by the Council for new equipment to be purchased.

Pulham Market Parish Council believe that play is a vital component of growing up and is how children develop skills, physical, social and intellectual.

This document is intended to guide Pulham Market Parish Councillors in their role as custodians of play equipment. This policy applies only to play equipment upon Parish Council land and is not applicable beyond this, such as equipment on private land.

The Management of Health and Safety at Work Regulations 1999 recommends that owners and managers of premises should undertake a risk assessment of their facilities - this includes the children's playground. This document defines and makes clear the duties and responsibilities of the parish council and how it manages play equipment within its boundaries. This also includes a risk assessment setting out the key hazards and the Councils risk mitigation process.

Background Information

Under the auspices of the Health and Safety at Work Act 1974 and Management of Health and Safety at Work Regulations 1999, owners and managers of premises must undertake a risk assessment of their facilities - this includes the children's playground.

Pulham Market Parish Council Play Area Management Policy Document – Risk Assessment

The Play Area Management Risk Assessment is formulated in accordance with HSE Guidance INDG 163 'Five Steps to Risk Assessment and guidance from Digley Associates.

The purpose of the document is to:

- · Assess the risks relating to play area management
- Provide a formal way for the Parish Council to identify and be notified of, or potentially dangerous, equipment within the play area
- Ensure the Council has sufficient information to make decisions on play equipment condition and management
- Ensure that play equipment damage can be detected in a reasonable time
- Ensure that dangerous equipment is properly dealt with and appropriate action taken

Control measures are then applied to the significant risks where the remaining residual risks are re-scored to ensure all risks are suitably managed and controlled.

All routine inspections will be undertaken in accordance with Information Sheet 24 provided by RoSPA, and will be recorded on the sheets provided by the Parish Council. All inspection reports will be handed to the Clerk to be retained within the Parish Council records.
